Protecting Auburn's Water Quality

The City of Auburn's Illicit Discharge Ordinance

The City of Auburn operates and manages a municipal storm sewer system under permit from the Alabama Department of Environmental Management. One requirement of this permit is that the City must implement a program to detect and eliminate illicit discharges from the storm sewer system into other bodies of water. An illicit discharge is defined as the discharge of anything other than pure stormwater into a body of water.



In 2004, the Auburn City Council adopted Ordinance No. 2192, the Illicit Discharge Ordinance, to protect Auburn's water resources. The City conducts weekly water quality monitoring and visual inspections at various locations where the stormwater system discharges into Auburn's lakes and streams. The City also investigates all reports of illicit discharge and enforces the penalties outlined in the Illicit Discharge Ordinance when violations are found.

You can help protect Auburn's water resources by reporting suspected illicit discharges. Citizens may access the Illicit Discharge Report form online at www.auburnalabama.org/wrm and click on the "Illicit Discharges" link on the left. Follow the instructions to submit or print a report.

Cable Television in Auburn



Many citizens ask why there is no cable television competition in Auburn. Some mistakenly believe that the City has an arrangement with Charter granting them a monopoly for cable television services. It does not.

The City of Auburn has a non-exclusive franchise agreement with Charter Communications. This agreement does not stop, or hinder, any other cable company from entering the Auburn market. City officials have spoken to several other cable companies about serving Auburn. As of this writing, no other cable provider has chosen to enter this market. The common reason given is that this market is not large enough to support the tens of millions of dollars in

infrastructure costs they would incur in providing service to the whole of Auburn.

Competition is provided for cable television via satellite television services, but many citizens do not choose satellite since "local" broadcast networks such as ABC, CBS, NBC, and FOX are not available on satellite in this area. Regulatory power to require satellite television to provide local channels rests with the Federal Communications Commission.

The federal government also regulates much of what the City's franchise agreement can require of any cable company. For example, local government has no authority over the rates a cable company may charge, or the channel line-up offered. The current franchise agreement with Charter does require them to maintain a physical location in the City to provide for subscriber inquiries, bill payments, and equipment transfers.

Research conducted by City staff shows that true competition for cable television services is somewhat rare in communities Auburn's size. Even in some larger communities that boast more than one cable franchise, the cable company's service areas do not overlap, meaning that no competition is provided.

As Auburn grows, and as technology progresses, the prospects for more sources of television competition will also grow. Digital television will continue to open up new possibilities for the delivery of television and other services to the home. City officials are continuing to talk to cable television providers in hopes of securing additional franchise agreements.

Auburn's Sign Regulations

The Auburn Municipal Code and the City of Auburn Zoning Ordinance set forth regulations regarding all signage within the Auburn City limits. Residents should familiarize themselves with these regulations. By working together, we can help ensure the legal, safe, and attractive placement of signs throughout the City and help keep Auburn beautiful.

Signs on Utility Poles and Traffic Signs

Signs and posters are prohibited from being posted on utility poles or traffic signs anywhere in the City of Auburn.



Signs in the Public Right-of-Way

Signs are prohibited from being posted in the public right-of-way throughout the City of Auburn. For Sale signs and Now Hiring signs are permitted only within the boundaries of a business or individual's property. No signs may be placed outside the boundaries of a business or individual's property line.

Real Estate Signs

All real estate signs must be located only on the property that is for sale, lease, or rent. Off-premise real estate signs, such as directional signs to the property, are prohibited. One real estate sign is permitted to face each street adjacent to the property that is for sale, lease, or rent. These regulations also pertain to For Sale by Owner signs.



Political Signs

The City of Auburn has the following regulations in place governing the placement of all political signs:

- Signs may not be placed earlier than thirty days prior to the election date.
- Signs may not be placed in the public right-of-way; on any structures in the right-of-way, including power poles and traffic signs; in road medians; or on any property owned by the City of Auburn or Auburn City Schools.
- Signs are limited in size to a maximum of thirty-two square feet.
- It is the candidate's responsibility to ensure that the volunteers who distribute and erect political signs are doing so in compliance with these regulations.
- Signs must be removed within seven days after the election date.

Because Every Drop Counts... Water Conservation Tips For March

Spring is just around the corner and many citizens will be heading outdoors to tend to their yards and plantings. The following water conservation tips will not only help you maintain a healthy lawn, but a healthy water supply for Auburn citizens.

A 3/4 inch rain can eliminate the need to water your lawn for 4 days

One of the largest consumptions of water is over-watering lawns. As a general rule of thumb, lawns only need watering every 5 to 7 days during the spring and summer.

Pavement does not need water

To get the most for your money, position sprinklers so that all water lands on your lawn or plants. Do not water sidewalks, driveways, or other paved areas.

Mulching plants can reduce water usage

Mulching results in better soil moisture retention and weed control. Effectively mulching your plants, trees, and shrubs reduces the amount of water needed to maintain plantings.
