How Many Roommates Can I Have? A Reminder of the City of Auburn's Residential Occupancy Regulations

As we welcome back students from the summer break, residents are reminded that the City of Auburn Zoning Ordinance sets forth limitations regarding residential occupancy in the City limits. Traditional residential neighborhoods are typically zoned to allow for no more than two unrelated persons to reside at an address. Apartment complexes, mobile home parks, and other multi-family housing units are properly zoned to allow for more than two unrelated tenants.

Not sure if you are in compliance with the Zoning Ordinance? Visit the City's website at www.auburnalabama.org/occupancy. The site contains links to the occupancy limitations map, the City's Geographic Information System (GIS) site, a brochure highlighting specific information on the City's occupancy limitations, and information on how to report suspected residences in violation of occupancy regulations. Residential occupancy brochures are also available at the City of Auburn Planning Department, located at 171 North Ross Street, Suite 100.



Property owners found to be in violation of occupancy regulations are subject to fines and possible jail time, as set forth in the City of Auburn Zoning Ordinance. Residents in violation of residential occupancy regulations may be subject to eviction by property owners.

Urban Wildlife

Have you ever spotted a fox, coyote, or raccoon in your neighborhood? Nationwide, incidents involving wildlife in commercial and residential areas, often referred to as urban wildlife, are on the rise. Many times, human activity can cause wildlife displacement, leading to increased sightings of animals in urban areas. The presence of greenspace as part of the urban landscape, including public parks, floodplains, and golf courses, can also provide an attractive habitat.

Urban wildlife can pose risks to humans, including disease. The City of Auburn Environmental Services Department's Animal Control Division works to keep citizens safe from wildlife in residential areas. Most urban wildlife moves during the early morning and late evening hours; however, daytime sightings are not uncommon. Movement patterns depend on varying factors such as displacement, the availability of food, and caring for young.

There are several steps you can take to ensure the safety of your family and property. Eliminating food and shelter sources for wild animals is the best line of defense against urban wildlife. The City of Auburn Animal Control Division also suggests the following steps to help discourage wildlife from coming onto your property:

- Leave pet food and water dishes indoors, especially at night.
- Secure all garbage containers.
- Clean and cover grills and smokers after each use.
- Keep garage doors closed.
- Never feed squirrels, raccoons, or other species.

Urban wildlife tends to be attracted to cool, dry, and dark places. Take a look around your property and make sure locations such as openings under your house, porch, or shed are not accessible to animals. Any potential nesting areas should be checked for wildlife before being properly sealed. Wildlife migrates to overgrown wooded areas. Lots should be kept clean and orderly to help deter wildlife that may seek shelter on your property.

Citizens are asked to be especially alert for wildlife exhibiting signs of distress, such as stumbling, movement in circles, or discharge from the eyes or nose. Never attempt to interact with or remove wildlife from any area. If you are experiencing problems with urban wildlife, please contact the City of Auburn Animal Control Division at 501-3090. For after-hours requests, please contact the City of Auburn non-emergency number at 501-3100. In the event of an emergency, please dial 9-1-1.

FEMA Floodplain Maps and Flood Insurance Study Update

Property Owners in Floodplain Encouraged to Contact Insurance Agent About Flood Insurance

Lee County and the City of Auburn are in the process of updating their Federal Emergency Management Agency (FEMA) Floodplain Maps and Flood Insurance Study. Property owners affected by the new proposed floodplain have been notified by mail and are encouraged to contact their insurance agent about purchasing flood insurance. Once the proposed maps are in effect, property owners wishing to purchase flood insurance will likely face higher premiums. The proposed maps are tentatively scheduled to go into effect in early 2010.

A Guide to Auburn's Sign Regulations

The City of Auburn Code and Zoning Ordinance set forth regulations regarding all signage within the City limits. Residents should familiarize themselves with these regulations. By working together, we can help ensure the legal, safe, and attractive placement of signs throughout the City and help keep Auburn beautiful.

Yard/Garage/Estate Sale Signs

Yard/Garage/Estate Sale signs are allowed on the property on which the sale is taking place. A sign may be placed in the yard of the sale on the day of the event and must be removed at its completion. Signs are prohibited outside the boundaries of an individual's property, including utility poles, street signs, and in the right-of-way.

Home-Based Businesses

Signs advertising a home-based business are prohibited throughout the City of Auburn.

Real Estate Signs

All real estate signs must be located only on the property that is for sale, lease, or rent. Off-premise real estate signs, such as directional signs to the property, are prohibited. One real estate sign, not exceeding six (6) square feet, is permitted to face each street adjacent to the property for sale, lease, or rent. These regulations also pertain to For Sale by Owner signs.

Model Homes/Open House signs cannot exceed six (6) square feet in area and shall not be displayed at any time when the property is not available for public viewing.

Signs on Utility Poles and Traffic Signs

Signs and posters are prohibited from being posted on utility poles or traffic signs anywhere in the City of Auburn.

Signs in the Public Right-of-Way

Signs are prohibited from being posted in the public right-of-way throughout the City of Auburn. Real Estate signs and Now Hiring signs are permitted only within the boundaries of a business or individual's property. No signs may be placed outside the boundaries of a business or individual's property line.

Hazard/Prohibition/Warning Signs

"No Trespassing", "No Parking", "Beware of Dog" signs, and the like, are permitted inside the boundaries of a business or individual's property line. These signs shall not be located in the public right-of-way, on utility poles, or attached to trees, rocks, or other natural features.

Political Signs

- Signs may not be placed earlier than thirty days prior to the election date.
- Signs may not be placed in the public right-of-way; on any structures in the right-of-way, including utility poles and traffic signs; in road medians; or any property owned by the City of Auburn or Auburn City Schools.
- Signs are limited in size to a maximum of thirty-two square feet.
- It is the candidate's responsibility to ensure that the volunteers who distribute and erect political signs are doing so in compliance with these regulations.
- Signs must be removed within seven (7) days after the election.
